Blood and Transplant



NHS Blood and Transplant (NHSBT) supplies blood to more than 260 hospitals, 365 days a year. Working with many different clients and agencies, NHSBT's data-sharing needs are complex and, as the only provider of blood donations in England, critical.

As technology has evolved, data sharing and collaboration has grown in importance and complexity. Increased demands place a higher burden on networks and systems. Individuals move on and new recruits, unfamiliar with existing scripts and processes, write new scripts. Over time, these ad hoc additions make systems slow and cumbersome. The system inevitably becomes more unwieldy and genuine current business requirements are harder to identify above the 'this is what we've always done' traffic.

Responsible for blood and organ donations, distribution and orders, lab systems and blood testing, the demands on the system are both complex and time critical. NHS Blood and Transplant's existing File Transfer systems were managing more than 400 jobs. Over time, it became clear that NHS IT systems needed to be upskilled to cope with future demands.

This need for an update was heightened further with complexity added by improved data protection legislation. For NHSBT to operate effectively in compliance with the myriad of new legal requirements, it needed a solution that would do more than meet the demands placed on it each day. It needed a system capable of managing future demands and the anticipated increase in complexity of these demands. The solution chosen would need to both integrate with NHSBT's output

reporting system and cope with modern-day security challenges, while remaining sympathetic to the bespoke architecture of the Service. Above all, it needed to be easy to maintain and flexible enough to add additional transfers while giving high level visibility that would provide operational and security enhancements to the organisation.

Establishing a robust solution in which flexibility and security are central

NHSBT had identified more than 100 technical requirements for the new system. With this information, Insight collaborated with HANDD Business Solutions (HANDD) to successfully bid under a competitive tender exercise which was scored against these requirements.

HANDD's extensive experience equips it with an extensive understanding of the Managed File Transfer space. Meanwhile, its core partner, Insight, has built a wealth of experience in the Public Sector. Together, they combined perfectly to create a dynamic team that accommodated the needs and complexities of such a unique project. The solution identifies areas of risk such as sensitive information, malware or high-risk executables as they flow

through the existing web proxy or managed file transfers. In doing so, it heightens the protection of critical information in motion.

Due to the volume of traffic and the time-sensitivity of many of the workflows and processes at NHSBT, HANDD recommended Globalscape be operated with a high-availability cluster to ensure optimal uptime and reliability. NHSBT chose to purchase and run two Globalscape solutions that sit behind a load balancer for failover, making the solution more robust and resilient and guarding against downtime.

The solution: A seamless switch to a more robust and secure solution

One of the challenges for NHSBT is the number of legacy PowerShell scripts that need to be converted. HANDD's experience of expediting conversion through automated workflows will enable speedier conversion for a more robust system long term.

HANDD will work with NHSBT to establish seamless integrations with additional security products and various existing applications. HANDD & Insight will also support NHSBT by delivering training to upskill the teams managing these integrations moving forward. 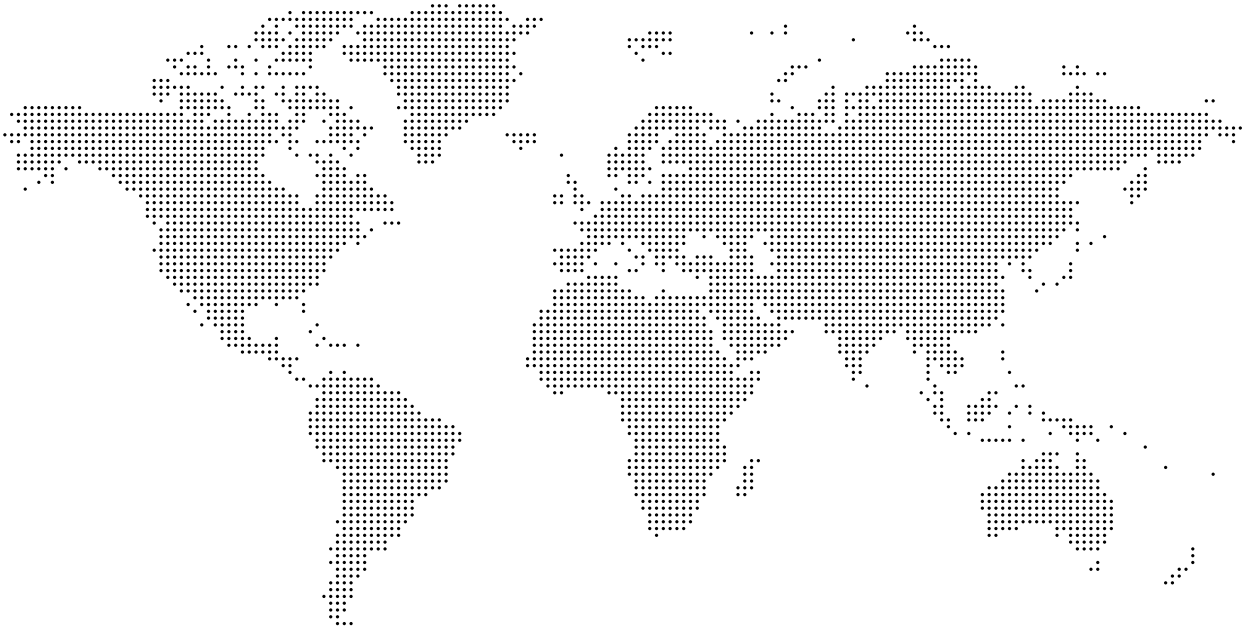
